IT IS FURTHER ORDERED, ADJUDGED and DECREED that Plaintiff, DELORES TIPP, recover THREE MILLION AND NO/100 (\$3,000,000.00) DOLLARS from Defendant, THE DOW CHEMICAL COMPANY in actual damages.

**Robert Tipp**

IT IS FURTHER ORDERED, ADJUDGED and DECREED that Plaintiff, ROBERT TIPP, recover ONE MILLION AND NO/100 (\$1,000,000.00) DOLLARS from Defendant, THE DOW CHEMICAL COMPANY in actual damages.

**Dora Cook**

IT IS FURTHER ORDERED, ADJUDGED and DECREED that Plaintiff, DORA COOK, recover ONE MILLION AND NO/100 (\$1,000,000.00) DOLLARS from Defendant, THE DOW CHEMICAL COMPANY in actual damages.

**William E. Tipp**

IT IS FURTHER ORDERED, ADJUDGED and DECREED that Plaintiff, WILLIAM E. TIPP, recover ONE MILLION AND NO/100 (\$1,000,000.00) DOLLARS from Defendant, THE DOW CHEMICAL COMPANY in actual damages

**Debra Wienkem**

IT IS FURTHER ORDERED, ADJUDGED and DECREED that Plaintiff, DEBRA WIENKEM, recover ONE MILLION AND NO/100 (\$1,000,000.00) DOLLARS from Defendant, THE DOW CHEMICAL COMPANY in actual damages.

**Phil Tipp**

IT IS FURTHER ORDERED, ADJUDGED and DECREED that Plaintiff, PHIL TIPP, recover ONE MILLION AND NO/100 (\$1,000,000.00) DOLLARS from Defendant, THE DOW CHEMICAL COMPANY in actual damages.

**John Tipp**

ORDERED, ADJUDGED and DECREED that Plaintiff, JOHN TIPP, recover ONE MILLION AND NO/100 (\$1,000,000.00) DOLLARS from Defendant, THE DOW CHEMICAL COMPANY in actual damages.

The Court finds that Plaintiffs, ESTATE OF WILLIAM C. TIPP, DELORES TIPP, ROBERT TIPP, DORA COOK, WILLIAM E. TIPP, DEBRA WIENKEM, PHIL TIPP and JOHN TIPP have been awarded a judgment against THE DOW CHEMICAL COMPANY in the total amount of NINE MILLION SIX HUNDRED THIRTY-SIX THOUSAND EIGHT HUNDRED TWENTY-FIVE AND 10/00 (\$9,636,825.10) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED and DECREED that Plaintiffs, ESTATE OF WILLIAM C. TIPP, DELORES TIPP, ROBERT TIPP, DORA COOK, WILLIAM E. TIPP, DEBRA WIENKEM, PHIL TIPP and JOHN TIPP recover from Defendant, THE DOW CHEMICAL COMPANY ONE MILLION EIGHT HUNDRED SIXTY-SIX THOUSAND SIX HUNDRED THIRTY-NINE AND 82/100 (\$1,866,639.82) DOLLARS in pre-judgment interest from

the date of filing, July 19, 2001, up to and including June 26, 2003, for a total judgment of ELEVEN MILLION FIVE HUNDRED THREE THOUSAND FOUR HUNDRED SIXTY-FOUR AND 92/100 (\$11,503,464 92) DOLLARS.

The Court further finds that Defendant, THE DOW CHEMICAL COMPANY, is entitled to offsets in the amount of SEVEN HUNDRED TWENTY-SEVEN THOUSAND FIVE HUNDRED EIGHTEEN AND NO/100 (\$727,518.00) DOLLARS to be subtracted from the amount of a ELEVEN MILLION FIVE HUNDRED THREE THOUSAND FOUR HUNDRED SIXTY-FOUR AND 92/100 (\$11,503,464 92) DOLLARS; and

IT IS THEREFORE ORDERED that Plaintiffs, ESTATE OF WILLIAM C. TIPP, DELORES TIPP, ROBERT TIPP, DORA COOK, WILLIAM E. TIPP, DEBRA WIENKEM, PHIL TIPP and JOHN TIPP have judgment against THE DOW CHEMICAL COMPANY in the total amount of TEN MILLION SEVEN HUNDRED SEVENTY-FIVE THOUSAND NINE HUNDRED FORTY-SIX AND 92/100 (\$10,775,946.92) DOLLARS, for which let execution issue.



IT IS FURTHER ORDERED, ADJUDGED AND DECREED that costs of court in the


amount of SIX THOUSAND ONE HUNDRED SIXTY-TWO AND 60/100 (\$6,162.60) DOLLARS be and hereby are taxed against Defendant, THE DOW CHEMICAL COMPANY, for which let execution issue if not timely paid.

TIPP, DELORES TIPP, ROBERT TIPP, DORA COOK, WILLIAM E TIPP, DEBRA WIENKEM, PHIL TIPP and JOHN TIPP, interest at the rate of ten percent (10%) per annum simple interest compounded annually beginning on the date of rendition of this judgment on the costs of court in the amount \$6,162.60 which interest shall continue to accrue on the unpaid balance until said sum if paid in full.
